3T's Rules and Regulations

Memberchip

- 1.0 When subscribing to a membership during a campaign period that inkcludes free training, applies 12 paying months after the free period is over.
- 1.1 The member must be 16 years of age or older. The signature of the guardian
- (1.5) is required upon the establishment of an Automatic Bill Payment contract. This applies until the member has reached the age of 18.
- 1.2 As a member of 3T in good standing, you will have access to any 3T-gym.

(1.7)

- 1.3 Upon signing of the contract your photograph will be taken in order to prevent
- (1.8) misuse. Entrance passages will be recorded in our database and are for internal use only.
- 1.4 3T undertakes to keep all necessary information about the use of debit
- (1.9) cards confidential. 3T's processing of personal data shall be in accordance with. The Personal Data Act and other relevant regulations.
- 1.5 You agree to follow the instructions and abide by the rules that at any time
- (2.3) apply to the use of the gym. 3T reserves the right to terminate the membership in the event of misuse.
- 1.6 You agree to use the membership card issued upon arrival. Lost or damaged
- (2.7) cards are replaced for a fee. If you have forgotten your membership card you must contact the reception to gain access. If you forget your membership card 4 times in the course of a 2 months period, you are required to pay a fee for the issue of a new membership card. The membership card is personal and cannot be used by others.
- 1.7 3T disclaims any liability for injuries to persons or property arising during
- (2.5) or as a result of use of the gym, including damage to clothing and loss of money, valuables or other things of value that might be lost.
- 1.8 The member is responsible for being medically fit in order to use the facilities
- (2.1) at 3T
- 1.9 For safety reasons, children have no access to the gym. The only exceptions
- (2.2) are during the hours 3T provides staffed child care, or during activities organized specifically for children. During such activities all children must be accompanied by an adult.
- 1.10 Membership "On Hold": You can put your membership on hold for 2 months
- (3.2) each year at a cost. The Membership can be put on hold for whole months only. This must notified in writing no later than 30 days in advance on a special form found at the reception. It is not retroactive.
 - Senior citizens are granted a payment break during periods of agreed period (f.ex. when traveling). 3T provides in this case a postponement of the binding period. (Refers to a minimum absence of 4 weeks and a maximum of 4 months.)
- 1.11 In case of illness: 3T does not refund paid membership fees in the event of (3.3) an illness occurring in the contract period that requires absence. With a written doctor's notice banning training for more than 3 weeks, your membership will be suspended for as long as necessary without extra cost. This must be clarified as early as possible in the sick period, as it does not have retroactive effect.
- 1.12 Transfers: A membership in the binding period can be transferred to another (4.1) person one (1) time during the contract period for a fee. A written transfer of membership must be filled out on a special form at the reception, and both you and the new member must be present. The new member receives a price according to qualification when direct debit is chosen. A new member can choose between paying the remaining months of the agreement in cash, or entering into a new direct debit agreement with 12 months. bindingtime.
- 1.13 Temporary Stop of Membership: Contracts with completed binding period can
- (4.2) be frozen in case of illness, education or work outside the district. Documentation is required. Membership can be stopped for up to 12 months free of charge with proper documentation.
- 1.14 Contracts that are still in the binding period can also be frozen for the
- (4.3) above-mentioned reasons, but here payments will go as normal throughout

- the binding period. The time of absence will be registered when the binding period is over, and your membership fees will be stopped for the same amount of time which you have been unable to use your membership.
- 1.15 During military service 3T will extend the binding time and payment.

(4.4)

- 1.16 You are obliged to inform 3T of any address and bank account changes.
- (2.10) The membership fee is non-refundable.

Locker room

- 2.1 It is forbidden to store belongings in lockers beyond 3T's opening hours. (2.6)
- 2.2 Please be considerate of other members when taking pictures or filming
- (2.11) inside the gyms. Always ask permission to use the pictures, if other members happen to be in the background or present in the pictures taken. Taking pictures and filming is prohibited in the locker rooms. (Selfies included.)

Training

- 3.1 3T can provide an individual training program based on the individual
- (1.1) member's physical condition.
- 3.2 Group exercise: The number of classes and activities are subject to change
- (1.2) from season to season. 3T reserves the right to cancel or terminate the classes listed in the schedule. 3T offers online booking of various services. Specific booking rules apply. (Here one must follow the current rules for this service.)
 - 3T provides no guarantee that the desired class will be available.
- 3.3 Swimming pool and Jacuzzi: 3T has no lifeguard at the pools; enter and
- (1.3) use these areas at your own risk.
- 3.4 You commit yourself to clean up/tidy equipment after use.

- 3.5 For health and environmental reasons please use decent and unoffensive
- (2.8) exercise clothing, and always use a towel. 3T reserves the right to point out improper fitness attire. Clean indoor shoes that do not cause marks or discoloration must be used in the fitness center.
- 3.6 You undertake to leave the activity areas 30 minutes before closing time.

- 3.7 Fees for unused online bookings will be invoiced, if one fails to appear at
- (4.5) pre-booked class or activity.

Other

- 4.1 The opening hours can be subject to change, particularly at Christmas,
- (1.4) Easter and during the summer season. In addition, some activities and areas of the gym may also be subject to closure due to maintenance or courses, seminars etc.
- 4.2 3T reserves the right to send out information and or advertising via mail / (1.6) sms / email.
- 4.3 The use of steroids and other performance-enhancing doping agents is (5.1) absolutely forbidden for any 3T-member. The complete list of forbidden substances is found at www.rentsenter.no. 3T can require a medical test in the event of suspected abuse. Refusal to take such a test or returning a positive test will result in the cancellation of your 3T-membership.
- 4.4 3T is not responsible for any obstacles or restrictions that reduce 3T's training offer to the member when conditions are beyond 3T's control and 3T could not predict or overcome the following of the relationship (Force majeure). The membership agreement is signed under Norwegian law. Disputes between the member and 3T shall be solved in amicable resolution. If this is not the case, either party may bring the dispute before the ordinary courts.
- 4.5 3T reserves the right to camera surveillance to ensure the safety of our employees and members.
